SECTION 2. TERMS AND CONDITIONS.

The following terms and conditions apply to your participation in the Sound Choice Verified Compliance Safe Harbor (VCSH) Program. To the extent that these terms differ from any other proposal, these terms will govern. The terms "you," "your," and "venue" apply to the venue whose contact information was provided on the preceding screen. The terms "we," "our," and "Sound Choice" refer to Slep-Tone Entertainment Corporation, Sound Choice Studios, Inc., and its related companies, agents, and attorneys.

1. Your participation in the VCSH Program is fully voluntary, and you may withdraw from the VCSH Program at any time, without notice.
2. We reserve the right to modify or cancel the VCSH Program at any time upon 60 days' written notice.
3. In order to participate in the VCSH Program, you must first complete a registration for each participating venue. Incomplete or inaccurate information will void your participation in the program. A complete registration contains accurate information in each category for which it is requested, including (without limitation) the venue's full legal name, business organization type, state of organization, and physical address.
4. You must also arrange for the completion of a host registration form for each host you hire, for whom you want to participate in the VCSH Program. The host registration form is supplied in the Forms section of the Safe Harbor website. To confirm your participation, fax the completed host registration form to us at the number indicated on it. You will receive, by return fax, e-mail, or telephone call

(at our option), a confirmation that the host registration form was received, along with a 10-digit host registration number. This number serves as the confirmation that you have entered the safe harbor for that host.

5. You may also confirm your participation with a particular host by supplying us with the host's valid 10-digit host registration number. We will confirm the validity of the host's registration number.
6. If we determine that a host you have registered with us is not operating according to our media-shifting policy or any aspect of federal or state law, we will notify you of our determination. The safe harbor provisions will terminate 30 days after that notification unless (a) you terminate your relationship with the host, (b) the host comes into compliance with our media-shifting policy as part of a settlement agreement, or (c) we determine that the host was compliant and our initial determination was in error. You must confirm to us, in writing, that you have terminated your relationship with the host, if that is your method of maintaining the safe harbor.
7. **THE SAFE HARBOR.** Subject to your participation in this program, your valid registration of your venue, and the completion of registration information for each host you hire to perform karaoke services, we covenant that we will not commence a suit against you for infringement of Sound Choice's intellectual property rights, or for state-law unfair competition, or for any other action sounding in tort or fraud, which suit is based solely upon the actions of a registered host. This Safe Harbor does not apply (a) after 30 days of our notification with respect to any host whom we determine to be not in compliance with our media-shifting policy, (b) to any venue that furnishes content for the performance of karaoke shows, with respect to that content, or (c) to any venue that has withdrawn from the program.
8. You agree that we may use the information you provide in connection with this program for any purpose we deem appropriate, including investigations of potential infringing activity, marketing purposes, data collection purposes, and information dissemination purposes. You also agree that the information you provide in connection with this program shall not be considered confidential in any respect, and that this information is not being provided in connection with settlement negotiations.
9. You agree that in the event that you are sued by another party based upon your participation in this program, we are not obligated to defend or indemnify you for any purpose. You have voluntarily agreed to participate in this program.
10. The offers made hereunder are void where they are prohibited or restricted by law.
